**PROMISED GIFT AGREEMENT**

This promise shall extend to and be binding upon my executor, administrator, heirs, and assigns. Should this gift not be completed during my lifetime, my failure to include a specific bequest of the Object(s) to the ITHF&M in my Will shall not release the executor or administrator of such Will from the obligation of delivering the Objects to the ITHF&M in accordance herewith. Should the Object(s) be loaned to the ITHF&M prior to completion of this gift, the ITHF&M will insure the object(s) while the Object(s) are on the premises of the ITHF&M for the value set by me and stated on the separate signed Incoming Loan Agreement. Conditions governing incoming loans to the ITHF&M have been previously agreed upon and can be found on the separate signed Incoming Loan Agreement. I and the ITHF&M agree that these Object(s) are unique and monetary damages will not be sufficient to compensate the ITHF&M for failure to complete the gift. Therefore, the ITHF&M may seek an injunction or other court order to prevent any transfer of ownership of the Object(s) before or after my death to any person or entity other than the ITHF&M.

I acknowledge that the ITHF&M may publicly refer to the Object(s) prior to the completion of this gift as a gift promised by me and after completion of this gift as a gift donated by me. I agree that the ITHF&M may act in reliance on this pledge, and that the pledge may be made known to the public in the course of encouraging other prospective donors to make similar commitments. I acknowledge that this is an unrestricted gift to the ITHF&M, and the ITHF&M has full discretion as to the use and disposition thereof. This agreement shall be governed by the laws of the State of Rhode Island and Providence Plantations.
